

# Queensland Ex-TC Alfred Disaster Recovery Payment

You may be eligible for financial support with  
the Australian Government Disaster Recovery Payment  
(AGDRP) through Centrelink

Disaster Recovery Payment is a lump sum payment  
of **\$1,000** per eligible adult,  
and **\$400** for eligible child under sixteen.

**To be eligible for Disaster Recovery Payment you must be:**

- an Australian citizen, on a permanent resident visa, or on a protected special category visa, \* **and**
- be sixteen or older, or
- if under sixteen and receiving payments at the time of this disaster; and
- adversely affected in a declared Local Government Area  
(see Page 3 & 4 for QR Codes to check declared areas)

\*Some New Zealand citizens may be eligible

# Further Eligibility Criteria for Disaster Recovery Payment

If you or a child you care for have been affected by one or more of the following:

- Your place has either been affected by the floods and has either been destroyed by the floods or it will need to be demolished,
- Your place has been structurally damaged by flooding, for example, the inside of your home is now exposed due to damage caused by the floods or that sewage has gotten into and damaged your place.
- Your major assets have been damaged, and can no longer be used or need to be replaced
- Your water tank is damaged and needs repairing or cleaning, or the water needs to be replaced,
- Assets must have a combined market value of \$20,000 or more, and can include buildings, vehicles, caravans, water tanks or large-scale machinery,
- You have had a serious injury, or you have an immediate family member who is an Australian citizen or resident who has died or is missing due to the floods.
